Trash Bins - Please be aware, trash bins should **NOT** be put out for pick up any earlier than <u>3pm</u> on the day <u>prior</u> to the pickup. The bins must be brought in by <u>end of day</u> on <u>day of</u> pick up.



Annual Dumpster Day - Saturday, May 19th, from 8AM to 12PM only.

Take this opportunity to get rid of all the stored items you no longer use. Dumpsters will be located in the Pool Parking Lot. NO PARKING is permitted from 7AM – 1PM in that area. Proof of residency is required. NOTE items below cannot be placed in dumpster.

Engine oil, any petroleum products, garden chemicals, i.e., fertilizer Insecticides, pesticides, poisons, solvents, drain solvents, paint Materials (latex or oil based paints, turpentines, shellacs, sealers, Mineral spirits & other paint related materials), gasoline, kerosene and Other flammable liquids, including containers used for these products, hazardous, medical and toxic wastes, explosive materials, liquid sewage septic materials, any drums with product left in them. No tires, construction debris, garbage or food waste.



Pool Bracelets– The 2018 pool pass will be new, orange, pool bracelets, issued to homeowners on **Dumpster Day**. **Five bracelets per unit** will be allocated. Please visit the pool parking lot and the gazebo to get your pool bracelets on **Saturday**, **May 19**th **from 8am -12pm and Sunday**, **May 20**th **from 1pm – 4pm**. **IMPORTANT**: <u>Proof of residency will be required and Owners accounts must be current in order to receive pool bracelets.</u>



Satellite Dishes - <u>Elmcrest HOA does not allow roof installations of satellite dishes</u>. While roof maintenance is the responsibility of the homeowner, damages caused by satellite installations may affect other roofs in line, along with costly repairs. Installations are allowed on the sides of the buildings only. Fines will be assessed on Homeowners' accounts for noncompliance.

STREET CLEANING – EASY STREET – TUESDAY, MAY 15, 2018

All vehicles must be moved from the Visitor/Guest/Pool parking lots by 8AM Tuesday, 5/15/18, or be subject to towing at owner's expense. It is recommended that you garage your vehicles and keep all windows and doors closed since there will be significant dust and dirt airborne.



WE LOVE OUT PETS - BUT, Community Rules are specific about pets <u>always</u> being leashed. This is a finable offense and this rule, as well as the rule about picking up pet waste, will be strictly enforced. Keep the community 'pet friendly' by observing the pet rules.

ADDITIONALLY, PLEASE REMEMBER IT IS ILLEGAL TO PARK ON ANY OF OUR STREETS. THE TOWN OF FISHKILL POLICE DO PATROL THE AREA AND HAVE ISSUED TICKETS. WE ALSO HAVE A TOW POLICY IN PLACE TO TOW ANY ILLEGALLY PARKED VEHICLES. PLEASE ADVISE ALL OF YOUR GUESTS OF OUR PARKING AND TOW POLICY. ANY VEHICLES THAT ARE TOWED WILL BE AT THE **OWNERS EXPENSE.**
